Generally, a DNA sample may be obtained from an individual for testing by consent, his DNA stems from his voluntary consent, which provided the same authority.

Laplace, in his *A Philosophical Essay on Probabilities* (1825), and d'Holbach, in his *The System of Nature* (1770), both defend the idea that the truth of determinism shows that free will is an illusion. Laplace gives a clear statement of the idea behind determinism when he writes,
